

ATTENTION TO ALL FOOD RETAILERS

NOTIFICATION OF AUTHORIZATION PROCESS FOR VENDORS TO PROVIDE WIC AUTHORIZED FOODS TO WIC PARTICIPANTS

By virtue of the powers and authority conferred by the Law No. 81 of Department of Health of March 14,1912, as amended, and 7 CFR§246.3 (b), the Secretary of the Department of Health of the Government of Puerto Rico and its Special Supplemental Nutrition Program for Women, Infants and Children (WIC) announces the opening of the process to authorize retailers (vendors). Authorized vendors may accept the Electronic Benefit Transfer Card (EBT) issued to WIC Program participants to redeem supplemental foods, infant formulas, medical foods, fruits and vegetables prescribed according to their medical-nutritional condition.

All interested food retailers may apply subject to compliance with the requirements established by the WIC Program in accordance with federal regulations contained in 7 CFR §246.12 and the vendors cost controls established by Public Law 108-265 of June 30, 2004, as amended.

The application requirements, the orientation schedule will be available through the WIC authorized vendor's web site (WICA) at www.comerciantes.wic.com.pr and in the web site of the WIC Program www.wic.pr.gov on Friday, December 23, 2022.

The application for the Vendor Selection Process will be available starting on Monday, January 23, 2023 in the WIC authorized vendor's web site, (WICA), whose address is: www.comerciantes.wic.com.pr. Applications may only be accepted electronically, submitted thorough WICA.

The deadline for submitting the application for authorization and the required documents is Tuesday, February 28, 2023.
