General Information

Every month there is a process that evaluates the beneficiaries that have been identified as having a HCHN Condition in order to assign them with the corresponding Rate Cell.

This process uses as input the CLM files that are evaluated by the ASES actuary in order to identify the last qualified encounter validating a HCHN category for a member. All details for this procedure are specified in the HCHN Standard Operating Procedure (HCHN SOP).

This document describes the Layout for the Files that the Actuary sends to ASES.

The information on this document is subject to continuous revisions and modifications that will be made available to all parts involved.
