



NOTICE OF PUBLIC HEARING

TO REPEAL REGULATION NO. 5961 OF MAY 7, 1999, AND TO PROMULGATE THE REGULATION OF FEES FOR THE DEMOGRAPHIC REGISTRY OF THE DEPARTMENT OF HEALTH

Pursuant to the powers and authority granted by Act No. 81 of March 14, 1912, as amended, known in Spanish as "*Ley Orgánica del Departamento de Salud*"; Act No. 24 of April 22, 1931, as amended, known in Spanish as "*Ley del Registro General Demográfico de Puerto Rico*"; and Act No. 38 of June 30, 2017, known in Spanish as "*Ley de Procedimiento Administrativo Uniforme del Gobierno de Puerto Rico*," it is proposed to promulgate the regulation known in Spanish as "*Reglamento para el cobro de derechos en el Registro Demográfico del Departamento de Salud*".

The purpose of adopting this regulation is to repeal Regulation No. 5961 known in Spanish as "*Procedimiento para el Cobro de Derechos del Registro Demográfico para la Expedición de Certificados de Nacimiento, Matrimonio, Defunción y Natimuerto. Y otros servicios*," issued on May 7, 1999; and to establish hereto regulation regarding the fees to be charged for the services provided by the Demographic Registry of the Department of Health.
